Bikeability Cycle Training

Dear Parent / Guardian

We are delighted to offer your child a place on a **Bikeability** cycle training course (to Level 2), at Reculver Primary School during the week commencing 6 June 2016.

Bikeability is a new and much-improved version of the classic Cycling Proficiency Test. The training will be delivered by CyclingAge CIC - a local Bikeability Accredited scheme organisation (www.CyclingAge.co.uk). The course is partly funded by East Kent & Coastal Schools Games Partnership and parents are asked to pay just £10 to the running of it. Payment will be collected by the school for the Training Company and will be CASH only in a named envelope – **ParentPay will not be used for this event.**

The course begins with a Bicycle Service to ensure that children's bikes are roadworthy (basic adjustments will be made if required and small parts replaced where necessary) and continues to include skills exercise games on the playground. This will then be followed by basic manoeuvres on local roads. Trainees will work in pairs with one instructor for each road session.

Whilst it would be preferable for your child to use their own bike, if your child's bike is too small, or we are unable to get it to a roadworthy condition, or they don't have a bike at the moment, we will be happy to lend your child a bike so they can the course. We will also have a limited number of helmets to lend.
